### **PUCKLECHURCH RECREATIONAL GROUND**

#### TERMS AND CONDITIONS OF USE

- 1. Use of Pucklechurch Recreational Ground must be booked in advance.
- 2. Changing facilities are available from the Community Association. Information regarding costs can be obtained from them on tel: 0117 937 210.
- Costs for hiring the playing area can be requested from the Parish Clerk
- 4. For block bookings, payment is required 28 days after date of invoice.
- 5. Sports teams are expected to carry insurance cover, as necessary, for their activities, making the relevant certificate available to the Parish Clerk before use.
- 6. Any fetes or event organisers requesting use of the Recreational field must send a copy of the relevant insurance certificate to the Parish Council before agreement for use is made.
- 7. The football club will be responsible for:
  - a. Marking out football pitches
  - b. Providing/maintaining Nets/Goal Posts
- 8. The Cricket Club will be responsible for maintaining the wicket.
- 9. All users will be responsible for the following:
  - a. the removal and storage of any posts, signs, flags, markers, or any other equipment, effects and litter from the field after use.

# 10. If this work has to be carried out through the Parish Council the users will incur relevant costs.

- 11. Users will be expected to report any damage to the clerk, in writing within three days, whether incurred during the time of use or otherwise.
- 12. The Parish Council will retain responsibility for the maintenance of the playing field facilities at the current level, ensuring the recreational ground is suitable for use.
- 13. The Parish Council will aim to ensure the cuts correspond with major events on the field.
- 14. No Vehicles will be permitted to drive on the Recreation field without prior permission from the Parish Council.
- 15. No horse riding is permitted on the Recreational Field without prior permission from the Parish Council.
- 16. The use of Chinese lanterns is strictly forbidden from the Recreational Ground due to the risk of fire.

### The Terms and Conditions of Use will be reviewed annually.
